REQUIREMENTS FOR A PEDDLER OR HAWKER LICENSE:

(Roadside sale of meats, poultry or seafood from any motor vehicle, trailer or other mode of transportation or by any other means than sale at a fixed place. Includes persons who make sales house to house who does not have a fixed place of business in the Parish of Ascension.)

A license is required for each motor vehicle and/or each trailer and/or each facility used in the conduct of such business by the license.

 2. Resident street address of applicant; (No post office box numbers)
 3. Age of applicant;
 4. License number of all motor vehicles to be used by the applicant within the Parish for the business applied for;
 5. Type of product to be sold by applicant;
 6. **Parish** sales tax identification number of applicant;
 7. Surety Bond in the amount of Two Thousand Dollars (\$2,000.00) naming Parish of Ascension as Obligee.

REGULATIONS FOR PEDDLER OR HAWKER

1. Obtain License from the Ascension Parish Building Department.
2. Display license in a conspicuous place to aid in consumer id of vendor.
3. Give consumer a sales slip showing the date of purchase and amount of purchase.
4. Do not do business within one-half (1/2) mile from a fixed place or establishment selling identical or similar products.
5. Provide evidence to the Parish, from the owner or person authorized to give permission, for use of the particular location from which the vendor proposes to sell his/her products.
6. Provide a certificate from the Parish Health Unit when the products to be sold are under the jurisdiction of the Parish Health Unit.
