Request for Qualifications (RFQ) will be received by the Ascension Parish Government Purchasing Office, 615 East Worthey Street, Gonzales, Louisiana 70737 until **October 06, 2022 at 3:00 p.m.** local time for the following:

The East Ascension Consolidated Gravity Drainage District #1 (EACGDD #1) and Ascension Parish Government (Parish) is soliciting qualification statements from experienced and qualified firms that will involve surveying and Subsurface Utility Engineering (SUE) services to support the EACGDD #1 and the Parish Department of Public Works as outlined in the RFQ Scope of Services (Section 1.3) in compliance with all Federal and State Regulations.

Businesses and firms who are a Louisiana or Foreign LLC or Corporation should be appropriately registered with the Louisiana Secretary of State, as contemplated by Title 12 of the Louisiana Revised Statures.
