Mechanical Services: West Ascension Fire Hydrant Repair/Replacement

Request for Proposals (RFP) will be received by the Ascension Parish Government Purchasing Office, 615 East Worthey Street, Gonzales, Louisiana 70737 until August 3, 2023 @ 3:00 PM local time for the following:

The Ascension Parish Utilities Department is soliciting professional service proposals for mechanical, inspection and testing work as required to support the proper operation of our fire hydrants. The scope of this work is for the repair, replacement, inspection and testing fire hydrants as per the scope of work given. Bidders are to provide the Parish with a detailed unit price rate sheet for their services. All technical information will be provided to the successful bidder(s), which refers to equipment manuals, operating manuals and technical information as required.

Firms/Individuals who are interested in providing services requested under this RFP **must submit six (6) copies of proposals by the date and time specified**. The information shall be received in hard copy (printed) version by: **Ascension Parish Government, Purchasing Department, 615 East Worthey Street, Gonzales, LA 70737** on or before 3:00 p.m. Central Standard Time on the date specified in the Schedule of Events.
