Emergency Chemical Response Services for The Cleanup of Oil and Chemical Spills

Request for Qualifications (RFQ) will be received by the Ascension Parish Government Purchasing Office, 615 East Worthey Street, Gonzales, Louisiana 70737 until September 7, 2023 @ 3:00 PM local time for the following:

The Parish of Ascension (Parish) wants to retain a contractor for emergency response services, to provide on-call emergency spill response, coordination, and cleanup services to support our Parish Operations and Maintenance efforts. The Service Provider shall provide all supervision, labor, tools, equipment, materials and service required in order to receive a call from the Parish and mobilize on-site within the Parish to contain, cleanup and dispose all waste generated from spill response. Services will also include removal and disposal of any spill containment devices and/or materials, including materials deployed by Parish.

Firms/Individuals who are interested in providing services requested under this RFQ **must submit six (6) copies of qualifications by the date and time specified**. The information shall be received in hard copy (printed) version by: **Ascension Parish Government, Purchasing Department, 615 East Worthey Street, Gonzales, LA 70737** on or before 3:00 p.m. Central Standard Time on the date specified in the Schedule of Events. Electronic submittals are permitted via <u>http://www.centralauctionhouse.com</u>; however, six (6) hard copies must still be submitted within 24 hours of the Proposal submission deadline.
