The Ascension Parish Government (Parish) is now seeking professional services to provide assistance and support for grant and project management disaster recovery services. The Parish is soliciting qualification statements for support for program management and grant management services for any legacy disaster projects as required as well as any future disasters in compliance with all federal and state requirements.
