The Ascension Parish Government Office of Emergency Planning is soliciting sealed proposals for Emergency Debris Removal for Natural Disaster(s). The Responsible Respondent must meet all required qualifications and specifications of this Request for Proposal in accordance with **The Federal Emergency Management Agency (FEMA), Administrative Requirements, Compliances and Regulations.**

Request for Proposals will be received by the Ascension Parish Government Purchasing Office, at 615 E. Worthey Street, Gonzales, Louisiana 70737 (mailing address PO Box 2392, Gonzales, LA 70707-2392) until **November 02, 2023 at 3:00 p.m. (CST)** for the following:

The above Request for Proposals must meet 2 CFR 200. Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments Procurement §85.36.

Respondent must also be able to provide emergency debris removal from local and private roadways within the Parish of Ascension. The contractor shall provide all services described herein and any other services required to complete the project. Activities include, but are not limited to, field operations, debris pickup, debris hauling and removing, debris staging and reduction, temporary debris storage site management and debris management.

All questions should be submitted within seven (7) days of 1st publication.

Written inquiries must be received by 3:00 p.m. CST on Tuesday, October 10, 2023. As specified in the Schedule of Events.
