Public Hearing Set for Road Infrastructure District Millage Rates

Parish President Clint Cointment announced a public hearing to consider road infrastructure district millage rates in Ascension Parish which will take place on Thursday, July 18, 2024, in the Council Chambers at the Ascension Parish Courthouse in Gonzales, located at 607 E. Worthey Road.

NOTICE OF PUBLIC HEARING

Notice is hereby given pursuant to Article 7, Section 23 (C) of the Louisiana Constitution and R.S. 47:1705(B) that a public hearing of the Ascension Parish Government will be held in the Council Chambers at the Ascension Parish Courthouse, located at 607 E. Worthey Rd, Gonzales, Louisiana on Thursday, July 18, 2024 at 6:00 PM to consider levying additional or increased millage rates for Parish Road Infrastructure Districts without further voter approval or adopting the adjusted millage rates after reassessment and rolling forward to a millage rate not to exceed the prior year's maximum. The estimated amount of tax revenues to be collected in the next tax year from the increased millage and the amount of increase in taxes attributable to the millage increase for each tax are as follows:
