Marvin Braud Pump Station Protection Levee Elevation and Upgrades Qualifications Statement Engineering Services

Request for Qualifications (RFQ) will be received by the Ascension Parish Government Purchasing Office, 615 East Worthey Street, Gonzales, Louisiana 70737 **until October 13, 2022 @ 2:00 PM local time for the following:**

Ascension Parish is seeking is soliciting qualification statements for engineering services to assist the Parish with preliminary engineering, design engineering, and inspections of this project in compliance with Disaster Recovery CDBG-MIT Program requirements. The agreement will be on a lump sum, fixed price basis (or cost reimbursement "not to exceed" basis), with payment terms to be negotiated with the selected offeror. Reimbursement for services will be contingent on the Parish receiving funding from the OCD/DRU. The maximum amount of engineering fees that can be with Disaster Recovery CDBG-MIT funds will be determined by the OCD/DRU and may require adjustments in the proposed contract amount.

Businesses and Firms who are interested in providing services requested under this RFQ **must submit one (1) signed unbounded original and seven (7) bound copies of qualifications by the date and time specified.** The information shall be received in hard copy (printed) version. Failure to submit the required number of copies may result in a finding of non-conformance. Originals should be clearly marked.
