The Ascension Parish Mosquito Control Department is requesting proposals experienced and qualified firms to provide Aerial Spraying for Mosquito Control in selected areas under this Request for Proposal (RFP) by **submitting one (1) unbounded original and five (5) bound copies of proposal by the date and time specified.** The submittal shall be received in hard copy (printed) version. The submittal shall be received in hard copy (printed) version by: Ascension Parish Government, Purchasing Department, 615 East Worthy Street, Gonzales, LA 70737 on or before the date and time specified in the Schedule of Events. Electronic submittals are permitted via <http://www.centralauctionhouse.com>, however, six (6) hard copies must still be submitted within 24 hours of the submission deadline. Failure to submit the required number of copies may result in a finding of non-conformance. Originals should be clearly marked.

The Ascension Parish Government shall not be responsible if the bidder cannot complete and submit a bid/proposal due to failure or incomplete delivery of the files submitted via the internet.

The Parish of Ascension reserves the right to disqualify any Bid, response to Request for Qualifications or Request for Proposals, if it is determined that the submitting business entity is not in good standing with the Louisiana Secretary of State or is not authorized to do business in the State of Louisiana. Must comply with the Louisiana State Board of Private Security Examiners standards.

For each contract in excess of twenty-five thousand dollars per project, the public entity shall require of the contractor a bond with good, solvent, and sufficient surety in a sum of not less than fifty percent of the contract price for the payment by the contractor or subcontractor to claimants as defined in R.S. 38:2241.

- NOTE: Ascension Parish Government requires a one-hundred percent performance bond for all public works contracts.

Public Works projects over \$50,000.00 require the use of state licensed contractors and subcontractors.
