## **Ascension Parish Declares State of Emergency Following Severe Weather**

**ASCENSION PARISH** - Ascension Parish President Clint Cointment has declared a State of Emergency in response to the severe weather that impacted the parish on March 4, 2025. The storm system, which included high winds and possible tornadoes, has caused damage and disruption across the area.

This emergency declaration allows Ascension Parish Government to take immediate action to protect residents and property, mobilize resources, and coordinate with state and federal agencies for disaster response efforts. The Parish Office of Homeland Security and Emergency Preparedness (OHSEP) has been designated as the primary point of contact for response and recovery operations.

The declaration is effective from 5:00 p.m. on March 4, 2025, through 5:00 p.m. on April 3, 2025. Residents are urged to report damage and stay informed through official parish channels.
